Eligibility

I declare that on 11th June 2019 I will be:-

- aged 18 or over; and
- a UK citizen, a Commonwealth citizen, a citizen of the Republic of Ireland or a citizen of a Member State of the European Union.

I also declare that (tick all that apply):-

- I am registered as a local government elector for the Parish of Sadberge
- I have, during the whole of the 12 months preceding 11th June 2019 occupied land or other premises in the Parish of Sadberge as owner or tenant
- During the whole of the 12 months preceding 11th June 2019 my principal or only place of work has been in the Parish of Sadberge
- During the whole of the 12 months preceding 11th June 2019 I have resided in or within 4.8 kilometres of the Parish of Sadberge

I further declare that to the best of my knowledge and belief I am not disqualified under section 80 of the Local Government Act 1972 or section 34 of the Localism Act 2011.

For your information, the main grounds for disqualification are:-

- Being employed by Sadberge Parish Council or holding a paid office (other than Chair, Vice Chair or Deputy Chair) under the parish council (including joint boards or committees)
- Being employed by an entity controlled by Sadberge Parish Council.
- Being the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order or a debt relief restrictions order or an interim debt relief restrictions order.
- Having within five years before [date] been convicted in the UK, Channel Islands or Isle of Man of any offence and been sentenced to imprisonment (whether suspended or not) for three months or longer without the option of a fine.

- Being disqualified under Part III of the Representation of the People Act 1983 (which relates to corrupt or illegal electoral practices and offences relating to donations) or the Audit Commission Act 1998.
