Minutes of the meeting held at 7 p.m. on Tuesday 6th March 2018

1. Apologies

There were no apologies.

2. Declarations of interest in items on the agenda

There were no declarations of interest in items on the agenda.

3. Minutes of the last meeting

The minutes of the meeting on 6-Feb-2018 were agreed to be a true record of the meeting.

4. Matters arising from previous meetings

- 4.1 Sadberge Village Hall CIO still does not have a lease on Sadberge Village Hall, but the wording of the new lease is close to being finalised.
- 4.2 The Clerk has contacted Darlington Borough Council's Street Scene Team about the blocked drain in the verge of Middleton Road near the Rectory.
- 4.3 The scaffolder's wagon has been removed from the road verge adjacent to Lea Close.
- 4.4 There was no news about the World War One fighter landing ground memorial.
- 4.5 The Clerk has written to Darlington Borough Council's Public Rights of Way Officer and the Tees Valley Mayor to ask them to look into the possibility of establishing a safe, off-road footpath / cycle path / bridleway between Sadberge and Middleton St. George.
- 4.6 Megan Myszka knows some qualified archaeologists who might be prepared to volunteer to provide the "watching brief" during the installation of the improved drainage near the entrance to Town Farm Field.
 - It was agreed to offer to pay the relevant person's travel expenses.
- 4.7 The Sadberge History Trail plaques are being printed. Each plaque will have a QR code linked to a specific page on the Sadberge web site, where people will be able to find further information about the relevant location.
- 4.8 Darlington Borough Council has identified funding including the Section 106 payments from the development on the east side of Middleton Road at the southern edge of the village that will enable the Our Bus service to continue for another four years beyond the end of March 2018. The service will continue to run on a Monday-only basis.
- 4.9 Councillor Brian Jones has spoken to Darlington Borough Council's Enforcement Officer about the (now vacated) site of the unauthorised dog training facility at The Willows on Hill House Lane.
- 4.10 There was no news about social media.

5. Risk assessment

The Parish Council reviewed its risk assessment and agreed that it is appropriate and satisfactory.

6. Telegraph poles

6.1 Several local residents have complained about the new telegraph poles that have been installed in Sadberge. At least one pole has been erected in an unsuitable position (outside South View).
